Mr R Byrne, from Sunny Glen, Reskivers spoke to the meeting about the application PA23/01443, Gobans, Reskivers listing his opposition and concerns 2. Mr K Bullen Goosemoor, Reskivers - gave objections to PA23/01443 106/23 3. Mr Donnelly – PA23/01443 – responded outlining points and mitigations for the 107/23 planning application he has submitted. 4. Other members of Byrne family with opposition comment to the application at 108/23 Reskivers. 4 THE MINUTES of the meeting held on Monday, 13th March 2023 had been 109/23 circulated previously and agreed as a true record. Resolved to adopt the minutes – Proposed Cllr Egerton seconded Cllr Laity. 5 MATTERS ARISING 110/23 73/23 - Clock Tower - clock mechanism has been inspected by the engineer. The clock needs a part which Cllrs Laity and Matthews think they can manufacture. Mr Colin Brown has spoken to Mrs Ingham about scaffolding being put in her garden so that repair work to the wooden structure of the building. She has given permission. 111/23 76/23 - Sand Park - work has continued and SW Water advises that work will be completed at the end of April. **PLANNING** 6 112/23 PA23/01291 – Construction of chalet to provide ancillary accommodation and 6.1 retention and adaptation with building operations of part of existing outbuilding to create a small stable block, not in compliance with condition 7 of planning permission PA21/04001 - Turnpike, Daddiport, Tregony. Proposed Cllr Matthews, seconded Cllr Egerton - Tregony with Cuby Parish Council feel that this application should be split into two sections: a/Construction of chalet to provide ancillary accommodation - the parish opposes this part of the application. It would be very prominent and visible on the skyline and constitute over development of site overall. Further detailed information is needed to discuss further. b/ Adaption with building operations of part of existing outbuilding to create a small stable block, not in compliance with condition 7 of planning permission PA21/04001 the parish council have no objections to forming a new stable block, but would expect

that a condition is added to the permission to demolish the existing stables built on the site latterly that did not have planning permission. This would ensure that the size of stable block on site does not become duplicated. - Carried

113/23 6.2 PA23/01443 – The proposal is to create new single storey commercial premises within the current boundary of the owners existing house and wider land area. Also we propose a change of use from the existing commercial associated with the main house to residential use Gobans, Reskivers, Tregony

Proposed Cllr Lytham, seconded Cllr Gray -

Tregony with Cuby Parish Council opposes the application.

There are three areas of concern to councillors:

Reduction of privacy to a neighbouring property

Access - concern has been raised about the shared access to 3 properties; and the possible problems with access onto a busy road

Siting of business in a new substantial building within the open countryside. Carried.

114/23 6.3 PA23/02380 – Altered window style and enclosed porch to north elevation; new sliding doors and patio to west elevation; rooflights and covered area to south elevation; internal alterations and associated works; new covered parking area – Turnpike Daddiport.

7. CORNWALL COUNCILLOR'S REPORT

Cllr German gave his report that there was nothing specific to report from residents of Tregony.

There has recently been an accident near Trewarthenick, when a milk tanker had left the road and gone over the bank into the valley. No one was hurt but it had lost its load. There is an ongoing police investigation to understand why the accident had happened. There was concern about how Cormac reacted to the situation – ie. Problems with road closure and diversions.

Cllrs asked if there should be a barrier along that stretch – that would be unlikely and not practical – not had major accident history, and as no serious injury the police would not record the incident. Will have to wait for the police to conclude investigations.

9 HIGHWAYS WORKING GROUP

9.1 Leaflets giving information about the proposal for a pedestrian crossing on Fore Street has been distributed to households throughout the village. The results/ comments have been summarised and circulated to councillors showing a range of comments for and against. After discussion it was proposed that the parish council agree in principle to pursue a crossing in Fore Street to make the area safer – proposed Cllr Egerton, seconded Cllr Floyd Norris. Carried.

Cormac will need to survey and draw up final plans (the feedback from parishioners should be forwarded to help) and there will then be further consultation.

10 YOUTH WORKING GROUP

Cllr Spackman has been working with Action for Children about solutions to provide a youth club in Tregony – he will report further at the next parish council meeting. Cllr German has given him information about the Communities Infrastructure Fund which will need a quick application if decided as it closes in June. He will be inviting the Head of Roseland Academy to attend a parish council meeting in the near future.

10 SUSTAINABILITY GROUP

The group will be meeting again to start work on the next part of the parish policy.

11 **CEMETERIES COMMITTEE**

120/23 Cllr Matthews reported that the committee have taken the decision to ask Sexton David Dingle to undertake the work of filling graves that have begun to subside.

The Committee have begun discussion about how to proceed/ look after the Old Cemetery.

The new gates have been hit, with the hanging damaged – now repaired.
